# Franklin Local School District Board of Education

**April 8, 2015** 

### **Opening Report**

The Franklin Local Board of Education held its regular monthly meeting on Wednesday, April 8, 2015 at the Central Office. Board members Jim Swingle and Larry McCutcheon were absent.

The Board heard from Rick Lawyer, Dean of
Students at Mid-East CTC and Philo High
School/Mid-East seniors Trevor Angler (Power
Line Program) and Ashton McCormick (Early
Childhood Education Program) on some of the
programs offered by the Career Center.

The Board congratulated the many student athletes and coaches who received post-season recognition.

#### PUBLIC PARTICIPATION:

The Board heard a review of district insurance from Mike Young of ALR Insurance. The Board approved health insurance broker, TPA, network and premium effective May 1, 2015 as well as ALR Insurance Services as the district's insurance broker, membership in the Ohio School Benefits Cooperative, Medical Mutual

as the District's third party administrator for medical and dental claims, Medical Mutual of Ohio as the medical provider network – SUPER MED, as well as a 5% increase to medical insurance premiums (\$294/month Family Plan - \$14/month increase), \$53.80/month Single Plan (\$2.60/month increase), and no increase to dental premiums effective May 1, 2015.

### Treasurer's Report

The Board reviewed the monthly financial report and investment activity, fund balances and list of bills paid, and green financial sheet during the previous month.

The Board waived the reading of and approved the minutes of the March 18, 2015 regular meeting.

The Board approved acceptance of donations for scholarships and 6<sup>th</sup> Grade Camp fees.

The Board approved purchasing new English Language Arts resources (Reading Wonders by McGraw Hill Publishers) for kindergarten through grade 3.

The Board approved a revised list of graduates from the Franklin Local Community School.

The Board approved a resolution to designate the week of May 4-8, 2015 as Teacher and Staff Appreciation Week (May 5 is Teacher Appreciation Day) and have the FLSD Food Service Department provide an appreciation lunch for each building during that week.

The Board approved the Latchkey Tuition Waiver for children of FLSD employees.

The Board approved the 2015-2016 S.K.I.L.L. (Safe Kids in Local Latchkey) Parent/Child handbook.

The Board approved the 2015 Summer School program.
